4 A BILL FOR AN ACT ENTITLED: "AN ACT TO ENSURE THE INTEGRITY
5 AND ACCOUNTABILITY OF PUBLIC OFFICIALS BY PROVIDING PRECISE
6 AND COMPREHENSIVE LANGUAGE IN THE PROVISIONS GOVERNING
7 IMPEACHMENT, THEREBY UPHOLDING PUBLIC TRUST AND
8 MAINTAINING THE RULE OF LAW, AMENDING SECTION 4.0109,
9 A.S.C.A."

10

11 Preamble:

12 WHEREAS, Public officials hold positions of significant authority and
13 responsibility, and their actions directly impact the welfare of the
14 people and the functioning of government; and

15

16 WHEREAS, the impeachment process of the Governor and Lt. Governor is a
17 critical safeguard to address instances of malfeasance, corruption, or
18 gross misconduct in office and must be outlined with clarity to avoid
19 ambiguity or misuse; and

20

21 WHEREAS, malfeasance in office is defined as the intentional performance of an
22 unlawful, wrongful, or dishonest act by a public official while
23 carrying out their duties, which undermines public trust and violates
24 their responsibility to act in the best interest of the people; and

25

26 WHEREAS, well-defined language in impeachment laws ensures that the process is
27 carried out fairly, transparently, and in accordance with constitutional
28 principles, protecting both the rights of the accused and the interests
29 of the public; and

2 WHEREAS, in American Samoa, the principles of accountability and respect are
3 deeply rooted in the culture and governance, highlighting the
4 significance of ethical leadership and our community's well-being;
5 and

6
7 WHEREAS, ensuring clear grounds and procedures for impeachment aligns with
8 the Samoan tradition of holding leaders accountable while fostering
9 transparency and unity, preserving the trust and respect between
10 leaders and the people they serve. This is evident not only in
11 government but also in families, villages, and churches; and

12
13 WHEREAS, this amendment to add language to the impeachment statutes will
14 safeguard the dignity and honor of our leadership and reinforce the
15 foundational values of mutual respect, service, and integrity. A robust
16 impeachment law reflects a government's commitment to ethical
17 leadership, justice, and the principles of good governance, reinforcing
18 public confidence in the democratic process.

20 BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

21
22 Section 1. Section 4.0109 is amended to read as follows:

23 "4.0109 Impeachment.

24 (a)The Governor and the Lieutenant Governor are subject to impeachment
25 and, upon conviction, shall be removed from office.

26 (b)The Governor or Lieutenant Governor can be impeached for malfeasance
27 in office, corruption, dereliction of duty, or other high crimes and misdemeanors

1 (b)(c)The Legislature shall provide for the manner, procedure, and causes for
2 impeachment including for conviction of felonies and for a course of conduct
3 amounting to a gross abuse of power, as defined by law.

4 (e)(d)The House of Representatives has the sole power to bring articles of
5 impeachment upon a vote of at least 2/3 of the entire membership. The Senate has
6 the sole power to try impeachment, with the Chief Justice presiding, and may not
7 convict unless at least 2/3 of the entire membership concur. The members when
8 sitting for that purpose shall be on oath or affirmation.

9 (d)(e)Conviction shall extend only to removal from office and
10 disqualification to hold and enjoy any office of trust, honor, or profit under the
11 Territory. The party, whether convicted or acquitted, is also liable to other
12 prosecution under the law.

13 (e)(f)At the appropriate time and in the appropriate manner, this section or its
14 substance should be considered as a Constitutional Amendment to the Revised
15 Constitution of American Samoa.
